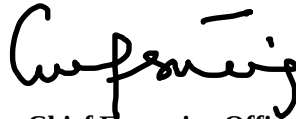

Notes:

- For Company Sdn. Bhd. or Bhd. the authorized person or representative attending the tender briefing and site visit shall be authorized personnel duly supported by the Board of Director's Resolution which is signed by the majority of the directors. The attendance of the director of the Company being the authorized personnel is preferred.
 - As for Partnership Company, the representative attending the tender briefing and site visit shall be authorized personnel duly supported by Power of Attorney of Letter of Authorization which is signed by majority of the partners. The attendance of the partner of the Company being the authorized personnel is preferred.
 - In the case of Sole Proprietorship, the representative shall be the sole proprietor or senior staff or top management staff of the company. The presence of senior or top management staff of the Company requires Letter of Authorization from the sole proprietor.
 - Proof of tenderer's attendance eg. verified attendance slip or any other form as given / specified in site visit and tender briefing is prerequisite for the purchase of all tender documents and the same document shall be submitted together with the tender document for technical compliance evaluation.**

 - Interested tenderer must bring their valid **Original or Certified True Copy Registration and License** as mentioned above and, **letter of authorization by the Company** to collect for prove before tender documents will be issued to them.
 - The documents shall be sold only to the owner or an authorized representative duly appointed in writing by the owner / partner / company director.
